No. GG/97/TTC/102002/1317 (Part-3)/V:- In exercise of the powers conferred by clause (s) of section 2 of the Code of Criminal Procedure, 1973 (2 of 1974) in its application to the State of Gujarat, the Government of Gujarat hereby amends the Government Notification, Home Department No. GG/36/TTC/102014/20/V, dated the 04th March, 2014, as under:-

In the said notification, in the Schedule


